


Right to Service Act implemented in Maharashtra

The 'Right to Service Act' has been implemented in Maharashtra. This means that now you won't have to visit government offices repeatedly to obtain documents like birth certificates, marriage certificates, licenses, etc.

A total of 43 government services will now be available to you at the click of a button, right from your home. To avail of these services, you will need to apply on the government website, and you will receive the required service within the stipulated time.

You will need to apply online on this portal. Government officials will be required to provide these services to citizens within the specified timeframe. This information was shared by Maharashtra's Housing Minister, Ravindra Waikar.

500 Maharashtra govt. services will soon be available on WhatsApp

An agreement was reached between the state's information technology department and social media giant Meta for developing a WhatsApp chatbox under 'Aaple Sarkar" initiative of the government.

The collaboration announced during the Mumbai Tech Week 2025, aims to provide all citizen services via WhasApp on a single number. This will

empower 125 million citizens to access government services from anywhere, at any time.

Boost for self-redevelopment projects as CM Fadnavis waives off interest on premium

The government's move to announce a waiver on interest of 8.5% charged for paying the premium over three years for self-redevelopment projects in Mumbai and other parts of the state is being seen as a progressive step towards urban renewal, providing housing societies with greater autonomy in redevelopment while

reducing financial strain.

Industry experts believe that the new policy will particularly benefit societies occupying plots smaller than 800 square meters with high FSI consumption, which constitute a large portion of Mumbai's redevelopment landscape.

BMC Begins Work On Multi-Level Robotic Parking Tower At Hutatma Chowk, Aims To Ease Congestion

he BMC has kicked off the construction of a state-ofthe-art Multi-Level Robotic Parking Tower (MRPT) at Hutatma Chowk. The ceremonial ground-breaking for this automated parking system took place on 5th March with former BJP Corporator Makarand Narwekar presiding over the event.



Once completed, the facility will provide much-needed relief to the area by offering a parking capacity for 194 cars, easing the parking woes in one of Mumbai's busiest areas, claims the civic official.

As part of its ambitious plan to address the city's growing parking challenges, the BMC is moving forward with the construction of multiple parking facilities across key locations. These include the BMC's Engineering Hub in Worli, near Mumbadevi Temple in Kalbadevi, opposite Matunga Central Railway Station, and at Hutatma Chowk near the Bombay High Court.

The total cost of these projects is estimated at Rs 504.19 crore. After facing strong opposition from local citizens, the proposal for a 23floor MRPT in front of Matunga East Railway Station has recently been scrapped. However, the BMC has officially commenced work on the first underground MRPT in South Mumbai.

As per the current plan, the MRPT at Hutatma Chowk will feature four underground levels, with construction costs amounting to Rs 70 crore. The site boasts a 12-meter access road on the western side and a



7-meter access road on the eastern side. Vehicles will enter from the eastern side and exit from the western side, ensuring smooth traffic flow.

The area above ground will serve as a holding area, where vehicles will be temporarily stationed before entering the parking facility. Utilising advanced lift technology, cars will be automatically transported to their designated parking spots. The



system is designed for efficiency, with a retrieval time of approximately three minutes.

Narwekar has called for more MRPT in key areas like Fort and near Regal Cinema, which are vital infrastructure hubs. "The Hutatma Chowk parking facility is a great step towards easing congestion near the Bombay High Court, but we continue to push for similar underground parking solutions at Kala Ghoda and Regal Cinema, which see heavy footfall. With ongoing area improvements, now is the time to act."

He also stressed the need for EV charging points at these facilities and insisted that maintenance be managed by the contractor with a 60-year defect liability period. Currently, the BMC provides parking for 40,000 vehicles in Mumbai-28,500 in public parking lots and 11,500 in onstreet spaces.

Activist Alleges Financial Irregularities In BMC's ₹504 Crore Multi-Level Robotic Parking Tower At Hutatma Chowk, Demands FIR Against Officials, Firms **Dhairva** Gajara

Activist Alleges Financial Irregularities In BMC's ₹504 Crore Multi-Level Robotic Parking Tower At Hutatma Chowk, Demands FIR Against Officials, Firms

ust a day after the BMC J started work for a multi-level robotic parking tower (MRPT) at Hutatma Chowk, civic activist Kamlakar Shenoy has raised objections against the project citing various irregularities. The activist has also alleged that the project will endanger people's lives and demanded legal action against the officials and private firms involved in constructing the parking tower.

The BMC kicked off the construction of a 23-storey MRPT at Hutatma Chowk on 5th March. The project, estimated at a cost of Rs 504.19 crore, is said to provide much-needed relief to the area by offering a parking capacity for 194 cars, according to the civic officials. The BMC spokesperson said all NOCs have been necessary received for the project. He said the same will be shown to Shenoy on 7th March.

However, civic activist Kamlakar Shenoy has raised objections against the MRPT and demanded to immediately halt the project as well as legal action against allegedly corrupt BMC officials. On 6th March, Shenoy wrote to the BMC Commissioner and alleged financial irregularities in the project, illegalities in the approval process, manipulation in the tender process and lack of public consultation.

Shenoy alleged that no genuine parking demand or feasibility study has been conducted or made publicly available and the project approvals appear to be based on fabricated or undisclosed data. He added that no independent, peer-reviewed traffic impact study has been published to justify this

project's efficiency to ease congestion. Heritage restrictions, legal requirements, and environmental impacts have been intentionally ignored to push this project forward, according to Shenoy.

Shenoy made a shocking allegation stating that the project has been undertaken without securing essential approvals including Mumbai Heritage Conservation Committee for development in the Grade I heritage zone, Urban Development Department for land-use change under DCPR 2034, Collector's Office for land allocation, Maharashtra Pollution Control Board for Environmental Impact Assessment, Mumbai Traffic Police for detailed traffic impact study and BMC's Tree Authority for tree cutting or relocation.

The activist alleged that the eligibility criteria in tender processing were structured to favor preselected bidders, while the project details, estimated costs, and tendering process have not been publicly disclosed. He also alleged that the project cost is artificially inflated, indicating financial mismanagement and possible corruption, demanding an immediate criminal investigation.

The BMC has also been accused of failing to conduct a public consultation or awareness programs before starting work for the project. Shenoy alleged that it is a violation of the citizen participation process mandated under urban development laws. He also demanded names of responsible officers and private firms involved in approving and facilitating Contd. on Page 4

Contd. from Page 1 that the housing societies undertaking self-redevelopment will be exempt from paying interest on the premium for the first three years – an initiative that will bring financial relief to many. This exemption will apply to all projects in the first phase, until March 2026. Additionally, we have special committee to sperehead its implimentation."

Bamasish Paul, co-founder, managing partner and CEO of Etonhurst Capital Partners, said the self-development model empowers societies by ensuring complete ownership, cost-sharing revenue retention. However, he noted that challenges such as financial constraints, project management complexity, and the need for consensusbuilding among members could hinder execution.

Approval costs and the purchase of Floor Space Index form a major component of redevelopment expensess in Mumbai. Developers typically opt for societies, restricted from taking loans under their charter, must pay this amount upfront. This often makes selfredevelopment less attractive," Paul said.

Nitin Singhal, founder of Absolute Group, emphasized that waiving the interest removes a key financial hurdle that previously made selfredevelopment less viable compared to developer-led projects.

"This is a well-calibrated step toward democratizing redevelopment, allowing smaller societies to take charge of their own renewal without relying on large developers. However, the real challenge lies in mobilising seed capital and ensuring that societies or professional development management firms have the expertise to execute project efficiently," Singal said.

He further highlighted that

many housing societies still lack the financial and technical expertise to navigate approvals, manage construction, and coordinate with key stakeholders, including financial institutions and local authorities

"Addressing these gaps through structured financing solutions, regulatory support, and professional DM services will be crucial in unlocking the full potential of this policy. Nevertheless, this move marks an important milestone in Mumbai's redevelopment ecosystem, particularly for smaller societies, making selfredevelopment a more viable and accessible option," Singhal added.

Wadala road cleared for commuters after 10 years, 600 vehicles removed

he BMC, in collaboration with the Antop Hill traffic police, removed more than 600 vehicles, many of which were abandoned or illegally parked near Dosti Acres in Wadala for more than 10 years, freeing up the road for commuters. During the drive, 150 two-wheelers were also fined and encroachments on footpath cleared.

The stretch from Shaikh Misri Shah Dargah (SMD) Chowk to Acharya Atre Nagar Monorail Station had become a major bottleneck for local residents, due to illegal car and two-wheeler parking, unauthorised construction of shops, and encroachment by hawkers.

Vaysingh Patil, senior inspector, Antop Hill traffic division, told HT that a nine-hour drive from 9:30am to 2:30pm was undertaken using a



100-strong team comprising police, traffic and civic officials. The team removed illegal hawkers, unauthorised extensions of shops, and encroachments on footpaths with the help of JCB machines.

"Out of 600 vehicles, 80 paid the fine and took their vehicles. The rest were towed. Announcements had been made for the last 15 days not to park on that road. Despite this, trucks and buses were also parked there illegally. It was a major inconvenience for commuters and pedestrians. Only those who were parking for free on this road are distressed now," said Patil.

Apart from immediately halting the project until all approvals are legally secured, Shenoy also demanded all project-related documents, NOCs, and approvals to be publicly disclosed as well as an independent audit into the tendering process and inflated costs. He also urged the civic body chief to register an FIR for financial fraud, misrepresentation, and corruption and initiate disciplinary action against BMC officials involved in this illegal approval process.

The letter also warned that if no corrective action is taken within seven days, Shenoy will initiate legal proceedings, including a public interest litigation (PIL) and criminal complaints against the concerned authorities.

"It is evident that the municipal commissioner and additional municipal commissioner have sanctioned this project based on misleading information, arbitrary decisionmaking, and non-compliance with legal procedures, thereby causing wrongful loss of taxpayers' money. These actions warrant an immediate investigation," said Shenoy. MMJ

Contd. from Page 3 half-km road, made one-way due to the work on Monorail Phase-II. worsened since the monorail service started, with more than 500 two-wheelers, taxis, cars and lorries parked illegally on one side of the road. "Now traffic flows smoothly on both sides of the road which had to be shut down for traffic earlier." said Patil.

Nitin Shukla, assistant commissioner. F north ward, said, "SMD road was full of encroachments, illegal structures, illegal parking, and abandoned vehicles. The road, which was two-way, was getting wasted. Now, that it has been cleared, the road can be used two ways for traffic and Wadala residents can go past SMD road without taking a circuitous route to reach Dosti Acres."
